At 7:01pm Gary opened the public hearing for SRK Holdings, LLC (f/k/a Ragged Mountain Pacific LLC, f/k/a RMR Pacific, LLC) and Ragged Mountain Resort Development, Inc. to approve certain amendments to the Amended and Restated Development Agreement between Ragged Mountain Pacific, LLC and the Planning Board dated September 8, 2015 and the related Cluster Residential Development Master Plan approved by the Planning Board on April 7, 2009 (as amended) to allow the use of funds in the Roadway Improvement Account created under the Development Agreement for certain improvements to Ragged Mountain Road. Discussion was held on this matter.

Bernie Golden made a motion to include in the Master Plan the document that is titled "SRK Holdings LLC/Ragged Mountain Resort – Amendment to Cluster Residential Development Master Plan for Road Maintenance and Repairs" as amended by the board tonight. The

ammendments are to include the following change: the word "Ragged Mountain Road" to "Ragged Mountain Resort" in the first sentence, deleting the two sentences starting "The road's deterioration....", and changing "New Conacha Road" to "New Canada Road" in the second paragraph.
