BOARD OF SELECTMEN MEETING MINUTES
Wednesday July 17 , 2024, 6:00 PM

Members present: Jessica Hatch, Chair, Ruby Hill , *James Farmer absent*
Also present, Maggi Fellows, Administrative Assistant, Bree Huntoon, Cam Huntoon, Jeremy Martin.

Chairperson Hatch opened the meeting at 6:07pm

At 6:08pm Jessica Hatch motioned to go into **Non-Public Session RSA 91-A:3, II(c)** Matters which, if discussed in public, would likely affect adversely the reputation of any person **other than a member of this board**, unless such person requests an openmeeting. This exemption shall extend to include any application for assistance or tax abatement orwaiver of a fee, fine or other levy, if based on inability to pay or poverty of the applicant. Ruby Hill seconded the motion, motion passed 2-0.

At 6:46pm Ruby made a motion to come out of Non-Public Session, Jessica seconded the motion, motion passed 2-0. Jessica made a motion to not abate John Taylors timber tax but will waive the interest that has accrued since John Taylor made his partial payment, Ruby seconded the motion, motion passed 2-0.

Fire Chief Martin questioned the possible use of the ARPA monies for replacement of portable radios last purchased 2002, this would be a rough cost of \$5000 per radio, 20 radios needed, or possible replacement of some of the older air packs at a cost of approx. \$50,000 for 7 packs,

Chief martin also asked about the sign at the dump stating they are not accepting brush for the burn pile, per order of the Fire Chief, he advised he has not placed that order.

Chief Martin also voiced his concerns for safety for the DART helicopter landing in the designated area with the construction of the sand shed not being completed and the bark mulch, stone , fence and ornamental trees being placed in the area of the landing zone.

At 7:36pm Ruby motioned to adjourn, seconded by Jessica. Motion passed 2-0. Meeting adjourned.
