Previous meeting minutes were reviewed. Roxanne Winslow made a motion to amend the minutes to more accurately reflect the conversation that was had. The recommendation was to change penultimate para to: "Jim Phelps initiated a discussion about the difference in definition in the LUZOs between "dwelling" and "travel trailers." More research will be conducted." Rick Swift made a motion to accept the minutes of July 10th, 2018, as amended, Will Cowen seconded. **Motion passed unanimously.** 

Reviewed the CIP Plan for 2018, after the changes were made from our last review, which were to re-allocate \$50,000 for the Forestry truck from years 2019 and 2020 to the years of 2020 and 2021. Other projects are in mind for next summer such as - Moving guest services office to the discovery center to make a better guest experience. Pave way for bathroom renovations in the main lodge next summer. Adding a new parking lot which is in the area of everyone would recognized as Forest Knolls West. Some trees are cleared.

Phil Hastings came before the board with questions on a prospective subdivision, that would be similar to the Corsetti property. Ragged would like the lots that would be included in this subdivision to be withdrawn from the master plan and development agreement, as was done with
