Previous meeting minutes were reviewed. Christine Caron made a motion to accept the minutes of May 25th, 2021, Jim Phelps seconded. **Motion passed unanimously.**

John Taylor opened the public hearing on the Capital Improvements Plan. The board reviewed the CIP from the previous year, line by line and made the appropriate changes. A draft will be emailed to the board and department heads prior to the next Planning Board meeting. A vote will be held at the next meeting to accept or amend the CIP.

Jamie Bemis came before the board to discuss plans that she had for land that she owns on Old Turnpike Road. She presented a proposed plan for a Cluster Residential Development. If/when the plan proceeds to the next steps, she will need to come before the board again.
